

Supernumerary round of Counseling for Union Territories (UTs) of Dadar & Nagar Haveli, Daman & Diu, Lakshadweep & Kandvi

As per the guidelines of the MHRD, there will be Supernumerary quota for the candidates having state of eligibility as UTs of Dadar & Nagar Haveli, Daman & Diu, Lakshadweep & Kandvi and Andaman & Nicobar Islands in some of the NITs. Details of the same are as detailed below:

1. Eligibility of candidates for Supernumerary round of Seat Allotment

[A] Following candidates are eligible for seats under Home State supernumerary quota at the respective allotted NITs.

- i. The candidates having their State code of eligibility as per Business rule of JoSAA 2017 or as notified for UTs/ as per their class XII certificate/ mark sheet

AND

- i. Candidates who did not get a seat till Special Vacant Seat Filling round. **OR**
- ii. Candidates who did not report against an allotment in earlier JoSAA round. **OR**
- iii. Candidates who reported against allotted seat to RC or PI but seat was cancelled due to change in category and are still un-allotted. **OR**
- iv. Candidates who reported against allotted seat to RC but withdrew the allotted seat till 6th Round of JoSAA.
- v. Candidates who have paid initial fee (Rs 45,000 for candidates with the category tag GEN, OBC-NCL and Rs. 20,000 for candidates with the category tag SC, ST, GEN- PwD, OBC NCL PwD, SC-PwD or ST-PwD) and reported against allotment of JoSAA 2017 *but did not report to the allotted Institute till 26th July 2017* for academic Session 2017-18.

[B] Following candidates are **not eligible** for seats under Home State supernumerary quota at the respective allotted NITs.

- i. Candidates who have been allotted a seat in JoSAA round and finally reported to the Participating Institute.
- ii. Candidates who have been allotted a seat in Special Vacant Seat Filling Round, irrespective of whether they have reported to the Participating Institute or not.

3. Fee to be paid at the allotted institute

Candidates who have been allotted a seat in Supernumerary round,

- i. if (s)he has deposited the *initial fee* (Rs 45,000 for candidates with the category tag GEN, OBC-NCL and Rs. 20,000 for candidates with the category tag SC, ST, GEN-PwD, OBC NCL PwD, SC-PwD or ST-PwD) will have to pay the balance fee (Institute fee minus *initial fee*) at the time of reporting to the allotted institute, if any.
- ii. if (s)he has not deposited the initial fee, will have to pay the whole institute fee at the time of reporting to the allotted institute, if any.
- iii. New notification of hike in Fees in NITs, if any, is applicable.

4. Rules of Allotment of seats in Supernumerary Round & Reporting

- i. All eligible candidates as mentioned above have the choice to participate in **Supernumerary round**.
- ii. Candidates are permitted to fill choices for all the branches as available in the published seat matrix. Allotment will be made only for balance number of seats (after deducting seats filled in normal course of allotment in Home State quota from the total supernumerary seats for that UT.

For example: There are 33 Supernumerary seats for Lakshadweep. Say, till special vacant seat filling round, 10 candidates from Lakshadweep have got admission in NIT Goa in Home State quota. Out of these 10 students, say, 4 candidates decide to withdraw from NIT Goa seat, resulting only 6 students from Lakshadweep retaining their seats in NIT Goa. Hence 27 (33 - 6) seats will be allocated in NIT Calicut for students of Lakshadweep according to their AIR.
- iii. All allotments will be made as per the merit based on **CRL Rank** only.
- iv. After the seat allotment, candidate can directly report to the allotted institute, get the documents verified, pay fee and take admission.
- v. The rules regarding category, PwD, Age, State of Eligibility, Qualifications, Original documents, restrictions etc. are the same as those specified in Business Rules of JoSAA-2017.
